## Recommendations on submission dates for Applicants of the Mutual Recognition Procedure (MRP)

This document was produced by the Coordination Group (CMDh) in order to facilitate planning of submission dates of new applications for Mutual Recognition. National holidays have not been taken into account when calculating the latest submission dates given in the Annex; applicants therefore have to consider this issue to allow 14 calendar days for validation for all Concerned Member States (CMS). Reference is made to the CMDh "Procedural Advice - Validation of MR/Repeat-Use/DC Procedures".

The CMDh would strongly advise applicants to discuss a timetable for the procedure with the Reference Member State (RMS) before the dossier is submitted to the CMS(s) and the RMS. This paper is meant as guidance and deviations might be accepted in certain cases provided that all involved parties agree.

The CMDh would also like to emphasise to applicants, that it is not mandatory to have a start date, which would automatically lead to a Day 75 at the same time as the scheduled dates for the CMDh meetings, as a break-out session is not routinely required for every procedure.

The CMDh has decided that the following principles would apply in order to ensure that crucial dates do not fall over the Christmas/New Year period (24th December to 1st January):

- i. *Validation* will not take place in the period 24th December to 1st January. Full 14 calendar days should be allowed outside this period. It might be preferable to split up the validation phase in two schemes, e.g. 7 days before Christmas and 7 days after New Year. Example: Submission on 16th December will allow 7 days of validation before Christmas and 7 days after New Year. The procedure can then be started on 8th January.
- ii. *Day 30* should not occur between 24th December and 1st January
- iii. *Day 55-60* should not occur between 24th December and 1st January and
- iv. *Day 85-90* should not occur between 24th December and 1st January

Furthermore, Day 90 should not occur on a Saturday or a Sunday. Saturdays and Sundays are not highlighted in the annex but this principle will be considered when the timetable is decided by the RMS.

The annexed overview allows the applicant to get a quick outline of not only the latest submission dates and with it the clock start dates (Day 0) but gives also a few of the other important deadlines within the Mutual Recognition Procedure.

The dates for possible break-out sessions have been highlighted. The CMDh would hereby also like to inform applicants, that the CMDh also accepts that the break-out session is held around Day 75 (day 73-80) and not only on Day 75.

The CMDh would like to draw applicant's attention to the CMDh document "Best Practice Guide on Break-Out Sessions/Hearings for Mutual Recognition and Decentralised Procedures" (current version) if a break-out session is considered during the procedure.
